**You are about to purchase a product that is not simple and may be difficult to understand.**

## What is this product?

**Type** The product is in the form of a certificate issued under English law. It is not an interest bearing security. The payment obligations of the product manufacturer are not guaranteed by any entity.

**Objectives** The product provides the potential for capital growth and does not pay interest. What you will receive at the end of the term of the product is not certain and will depend on the performance of the index MSCI USA Inflation Sensitive Select 50 5% Decrement EUR Index (the **underlying asset**). The term of the product will end no later than May 31, 2027. However, the product may terminate early depending on the performance of the underlying asset. Each certificate has a face value of HUF 100,000. The issue price is 100.00% of the face value. The product is not listed on an exchange. The subscription period is from May 9, 2022 to May 23, 2022. The issue date is May 31, 2022.

**Autocall feature:** If the closing price of the underlying asset on any autocall observation date is at or above 100.00% of the initial reference price, the product will terminate on the corresponding autocall payment date. In this case, you will receive an autocall payment for each certificate that you hold. Autocall observation dates are each trading day rolling semi-annually from May 24, 2023 (inclusive) to May 24, 2027 (inclusive). Autocall payment dates are dates falling 5 business days after each autocall observation date. Autocall payment for the first autocall payment date is HUF 109,500.00 and will subsequently increase by HUF 4,750.00 with each autocall payment date.

**Repayment at maturity:**

This section applies only if no autocall occurs as described above.  
 On May 31, 2027, you will receive HUF 100,000.00 for each certificate that you hold.  
 The initial reference price of the underlying asset is the closing price on May 24, 2022.  
 The autocall barrier is 100.00% of the initial reference price.

The product terms also provide that if certain exceptional events occur (1) adjustments may be made to the product and/or (2) the product issuer may terminate the product early. These events are specified in the product terms and principally relate to the underlying asset, the product and the product manufacturer. The return (if any) you receive on such early termination is likely to be different from the scenarios described above and may be less than the amount you invested.

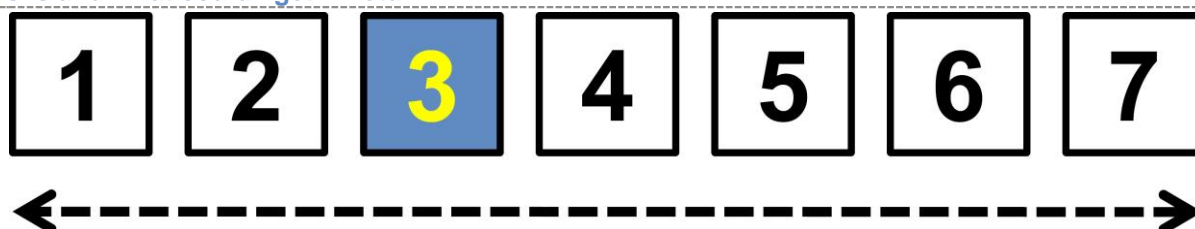
**Intended retail investor**

The product is intended to be offered to retail investors who:

1. have the ability to make an informed investment decision through sufficient knowledge and understanding of the product and its specific risks and rewards, with experience of investing in and/or holding a number of similar products providing a similar market exposure;
2. seek capital growth, expect the movement in the underlying asset to perform in a way that generates a favourable return, have an investment horizon of the recommended holding period specified below and understand that the product may terminate early;
3. accept the risk that the issuer could fail to pay or perform its obligations under the product but otherwise are not able to bear any loss of their investment;
4. are willing to accept a level of risk to achieve potential returns that is consistent with the summary risk indicator shown below; and
5. are making use of professional advice.

## What are the risks and what could I get in return?

**The risk indicator assumes you keep the product for 5 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less. You may not be able to cash in early. You may have to pay significant extra costs to cash in early.**

Higher risk

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 3 out of 7, which is a medium-low risk class. This takes into account two elements: (1) the market risk - that the potential losses for future performance are rated at a medium-low level; and (2) the credit risk - that poor market conditions are deemed very unlikely to impact our capacity to pay you.

You are entitled to receive back at least 100.00% of the face value of the product. Any amount over this, and any additional return, depends on future market performance and is uncertain. However, this protection against future market performance will not apply if you cash in before May 31, 2027. If we are not able to pay you what is owed, you could lose your entire investment.

Market developments in the future cannot be accurately predicted. The scenarios shown are only an indication of some of the possible outcomes based on recent returns. Actual returns could be lower. #### What are the costs?

The costs shown in the table above represent how much the expected costs of the product would affect your return, assuming the product performs in line with the moderate performance scenario. Disregarding the impact on your return in that scenario, the estimated entry and exit costs as a percentage of the face value are estimated to be 11.17% if you cash in after year 1, 12.22% if you cash in after 3 years and 9.02% if you cash in after the recommended holding period.

The costs shown in the table above represent the split of the reduction in yield shown in the costs over time table at the end of the recommended holding period. The split of the actual estimated costs of the product is estimated to be as follows: entry costs: 9.02% and exit costs: 0.00%.

### How long should I hold it and can I take money out early?

#### **Recommended holding period: 5 years**

The recommended holding period for the product is 5 years as the product is designed to be held until maturity; however the product may terminate early due to an autocall or an extraordinary event. You have no contractual right to terminate the product prior to maturity. The manufacturer is under no obligation to make a secondary market in the product, but may repurchase the product prior to maturity on a case-by-case basis. In such circumstances, the price quoted will reflect a bid-ask spread and any costs associated with unwinding the hedging arrangements of the manufacturer in connection with the product. In addition, the person who sold you the product may charge you brokerage fees when you sell the product back to the manufacturer.
