<u>Type</u>

This product is an unsecured debt instrument governed by English law.

<u>Term</u>

This product has a life span of 2 years 6 months but can be redeemed earlier according to the conditions indicated in the "objectives" section below.

Objectives

The objective of the product is to provide a periodic coupon, which is conditional on the value of the Reference Rate. It is possible for the product to be automatically redeemed early based on pre-defined conditions. Your capital will be fully at risk when investing in this product.

Range Accrual Coupon:

if the product has not been previously redeemed and at the end of each Observation Period, you will receive the Range Accrual Coupon multiplied by the ratio (n/N). Where:

- n is the number of Business Days within a given Observation Period in which the Reference Rate is observed at or above the Lower Range Barrier for that period and at or below the Upper Range Barrier for that period.

- N is the total number of business days in the Observation Period.

An Observation Period corresponds to 6 months and extends from (and including) a Valuation Date to (and excluding) the following Valuation Date. There are five Observation Periods.

Automatic Early Redemption:

On any Early Redemption Observation Date, if the level of the Reference Rate is at or below the Early Redemption Barrier, the product will be redeemed early and you will receive 100% of the Nominal Value in addition to any coupon due for the same period.

Final Redemption:

On the Maturity Date, if the level of the Reference Rate is at or above the Final Barrier, you will receive 100% of the Nominal Value converted in HUF at Predetermined Exchange Rate. In this scenario, you will suffer a loss that can be partial or total. Otherwise, you will receive : 100% of the Nominal Value in EUR.

Additional Information:

- -The Reference rate is observed daily at the Fixing Time.
- Coupons are expressed as a percentage of the Nominal Value.
- Coupons are paid on the Coupon Payment Dates corresponding to each Observation Period.

WHAT ARE THE COSTS?

Costs over Time

HOW LONG SHOULD I HOLD IT AND CAN I TAKE MONEY OUT EARLY?

Recommended Holding Period: 2 years 6 months, which corresponds to the product maturity.

Under normal market conditions, Société Générale or an entity of its group ensures a daily secondary market during the life of the product by providing bid and offer prices expressed as percentages of the Nominal Value and the difference between the bid and offer prices (the spread) will not be more than 1% of such Nominal Value. If you want to sell the product before the Maturity Date, the price of the product will depend on market parameters at the time you wish to sell and you may sustain a partial or total capital loss. In unusual market condition, the resale of the product may be temporarily or permanently suspended.
