"announcement for corporate clients" - amendment

K&H Bank Zrt. hereby informs its clients that, due to the reason(s) and as of the date(s) specified below, it is amending its announcement titled "Announcement for corporate clients" (hereinafter: **Announcement**) as detailed herein. The provisions of the Announcement not affected by this amendment shall remain in effect as they are.

Reason(s) for this amendment:

The corporate announcement will change as of 6 April 2020 for the following reasons:

The Bank amends its Corporate Announcement

- pursuant to Section 3.3.1 of the General Contracting Terms and Conditions (GCTC) on payment and deposit services provided for corporate clients, for the following reasons:
 - 1. The Bank unilaterally modifies the terms and conditions set out in the Announcement in view of, and adjusted to the increase in the Bank's procurement costs incurred due to the IT developments related to its activities and operating conditions, based on the changes in regulations namely Directive (EU) 2015/2366 of the European Parliament and of the Council (PSD2) and legally binding EU Regulations with regard to Regulatory Technical Standards (RTSs) supplementing the above Directive, as well as the accordingly amended Act LXXXV of 2009 on the pursuit of the business of payment services, and the amended provisions of MNB Decree No. 35/2017 (XII.14.). The amendment only applies to account package fees and account management fees, and does not affect transaction fees. The affected account packages will continue to include free-of-charge transactions, which will also ensure the free use of instant payments to be introduced on March 2, 2020,
 - 2. also the Bank unilaterally modifies the terms and conditions, including transaction fees, specified in the Announcement, in view of changes in the consumer price index,
 - furthermore, the Bank also amends the provisions pertaining to the determination and application of exchange rates applicable for the alignment of EUR-denominated fees of international EUR and SEPA payments within the EEA with the fees of domestic HUF payments.
- pursuant to Section 3.2.1 of the General Contracting Terms and Conditions (GCTC) on active corporate banking services (credit, loan, bank guarantee, letter of credit and financial lease transactions), for the following reasons:
 - in view of and in accordance with the change of the consumer price index, the Bank unilaterally modifies the conditions specified in the Announcement,
 - 2. an urgency fee (letter of credit, documentary collection) is introduced for legal relationships established between the Client and the Bank after 06 April 2020.

IV. REGULATIONS CONCERNING GENERAL TRANSACTIONS, ACCOUNTS

The Bank adjusts the EUR-denominated fees charged for EUR and SEPA cross-border payments in the EEA to the fee charged for domestic HUF payment transactions initiated from a domestic HUF account. When setting the fees announced in advance in the Announcement, the Bank applied the K&H FX I mid-rate as of 15 October 2019 as the reference rate. From 2020 on, the Bank revises, once a year, the applicable reference rate, which is calculated based on the K&H FX I mid-rate first quoted in the given year and applicable from April of the given year, when the conditions are modified due to the change of the annual consumer price index. The Bank shall recalculate the fees charged for EUR and SEPA payments within the EEA, taking into account the fees of domestic HUF payment transactions on the date when the Announcement takes effect, using the reference rate applicable on the same day.
