K&H Bank Zrt. hereby informs its clients that, due to the reason(s) and as of the date(s) specified below, it is amending its announcement titled "Announcement for corporate clients" (hereinafter: **Announcement**) as detailed herein. The provisions of the Announcement not affected by this amendment shall remain in effect as they are.

Reason(s) for this amendment:

The corporate announcement will change as of **1 July 2022** for the following reasons:

In accordance with the provisions set out in Section 3.3.1 of the GCTC on payment and deposit services provided for corporate clients, the Bank amends this Announcement as follows:

- The possibility to submit a transfer order via tested fax has been eliminated by the Bank. From now on, only bulk cash withdrawal orders will be submitted in encrypted form, which justified the "Order submitted via tested telefax" service has been moved from chapter 3.3 "OTHER SERVICES RELATED TO PAYMENT TURNOVER" to chapter "3.1 OTHER FEES RELATED TO CASH TURNOVER" with a modified name: "bulk cash withdrawal orders in encrypted form",
- new parameter of the device required for using K&H mobilbank.
